<p>Individuals with a new, continuous cough, high temperature or loss / change of smell and taste</p>	<p>E,C,V,YP,PW</p>	<p>Coronavirus reportedly spread through exposure to or contact with cough droplets</p>	<p>3</p>	<p>4</p>	<p>12</p>	<p>Testing – Individuals with symptoms must not come into work and must book a PCR test to check whether they have COVID-19 as soon as possible. Stay at home and do not have visitors (self-isolate) until you get your test result – only leave your home to have a test. Check if people you live with also need to self-isolate. If you are worried about your symptoms call 111. Workers must self isolate for 10 days if they test positive. It is a legal requirement to self-isolate if you are contacted and told to by NHS Test and Trace. Workers are encouraged to take regular lateral flow tests</p> <p>Communication – If an individual starts to display any symptoms during work time, they must inform their supervisor or manager immediately, leave work, book a PCR test as soon as possible and self-isolate until the test results come through</p> <p>Infection control procedures in place - Infection control procedures in place and communicated to all employees. Pay particular attention to coughing and sneezing into tissues that are disposed of in closed lid bins. Wash or sanitize hands immediately</p> <p>Restrict access - Restrict access to those showing symptoms until they have left Company premises. Contact should be restricted to minimum 6ft (2 meters) away from the affected person. Areas occupied by the individual should be thoroughly disinfected immediately after they have left the facility</p> <p>Face Coverings – Individuals with the onset of symptoms during work time must wear a suitable face covering (surgical type or similar) until they have left work premises</p>	<p>2</p>	<p>4</p>	<p>8</p>

Visitors are not permitted to enter the facility if they are showing any symptoms of COVID19</p> <p>Occupancy – Workers are permitted to work from home with approval from their supervisor or line manager. The Company operates staggered start and finish times to minimize interaction at peak times</p> <p>Face coverings - There is no legal requirement to wear a face covering in the workplace or enclosed public space. However, the Company supports individuals who wish to do so and these will be provided on request. 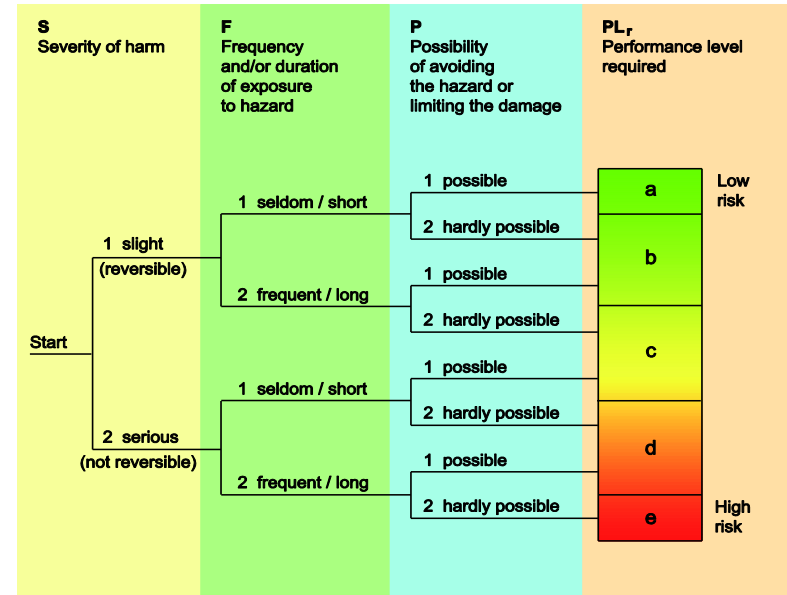

Lone workers can also have constant access to call staff should they show symptoms of Coronavirus or come in contact with those displaying mild symptoms</p> <p>Sanitizers - Only suitable sanitizers used that fully remove virus</p> <p>Reporting procedures followed - Those experiencing symptoms or who have come in to contact with those that have should call 111 for further advice and guidance on next steps, including potential self- isolation</p> <p>Face coverings – Although there is no legal requirement to wear a face covering in the workplace or enclosed public space, employees or contractors working on behalf of Expert will wear a face covering if requested on clients’ premises.
